Investment Objective

To achieve a return (before fees and tax) that exceeds CPI increases by at least 4.5% per annum over rolling six year periods and to limit the incidence of a negative annual return to one in any four-year period.

To achieve a return (over the medium to longer term) which is competitive with comparable funds that have a similar allocation to growth assets and similar risk characteristics.

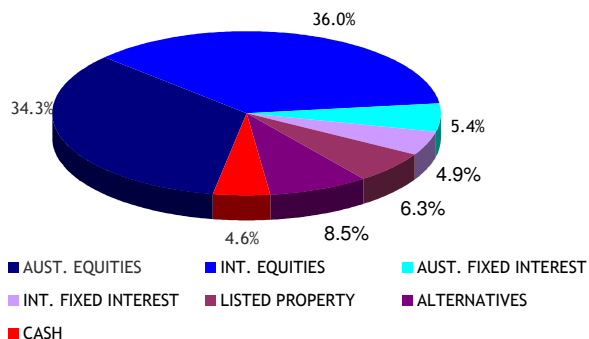
Investment Strategy
